HIGH SCHOOL DIPLOMA

- A copy of your high school diploma NOTE: In the State of Utah, a Certificate of Completion is not considered a valid high school diploma or recognized equivalent. An Electronic High School diploma recognized by the Board of Education following determination by your resident school district that you have completed high school graduation requirements as set by the Board is acceptable. A high school diploma issued by high school education programs collaborating with local education agencies is also acceptable.
- A copy of your final official high school transcript that shows the date when the diploma was awarded
- If you are a student who completed secondary education in a foreign country and are unable to obtain a copy of your high school diploma or transcript submit a copy of the "secondary school leaving certificate" or other similar document

RECOGNIZED EQUIVALENT OF A HIGH SCHOOL DIPLOMA

- A copy of your General Education Development (GED) certificate or GED transcript
- A copy of your State certificate or transcript received after passing a Stateauthorized examination (such as the HiSET or TASC) that the State recognizes as the equivalent of a high school diploma. NOTE: *The State of Utah does not offer a state* sanctioned test that is recognized as an equivalent to a high school diploma.

- An academic transcript that indicates you successfully completed at least a two-year program that is acceptable for full credit toward a bachelor's degree at any participating institution

HOMESCHOOL

- If you are homeschooled and State law (in the state where you were home schooled) requires a homeschool student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a copy of that credential. NOTE: In the state of Utah law requires homeschooled students to obtain either a high school diploma or GED, or a diploma that is recognized by the Board of Education from the Electronic High School so long as it has been determined by your resident school district that you completed high school graduation requirements as set by the Board.
- If you are homeschooled and State law (in the state where you were home schooled does not require a homeschooled student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a transcript or the equivalent signed by your parent or guardian, that lists the secondary school courses the student completed and documents the successful completion of a secondary school education in a homeschool setting

Additional supporting documentation may be required --such as, but not limited to:

Documentation of State law where student attended school,

Verification that document received is recognized by the State
