Pell Grant Eligible Programs

Pre-requisite, pre-admission and on-line courses are not eligible for Pell funding. Eligibility to receive federal aid may be limited for students choosing to enroll in more than one program/*certificate*. Please visit the Financial Aid Office for more information on how concurrent or consecutive program enrollment may affect your aid.

*This program/certificate is available to students who declared this certificate and began training prior to July 1, 2016 (in 15-16). Students whose start date is July 1, 2016 or later may not choose this program/certificate.

**This program/certificate is available to students who declared this certificate and began training prior to July 1, 2017 (in 16-17). Students whose start date is July 1, 2017 or later may not choose this program/certificate.

 Δ The State of Utah requires successful completion of a minimum of 1600 hours and the State of Idaho requires successful completion of a minimum of 2000 hours to become eligible to take the state license exam. The 400-hour difference in certificate length is actual time a student will be working with clients performing services in the lab environment. Students are encouraged to discuss certificate options with the Cosmetology Department Head prior to selecting in which option they wish to enroll (effective July 1, 2013).
